SECTION 4 - FIRST-AID MEASURES

Inhalation: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then, give artificial respiration, preferably mouth-to-mouth. Call a poison control center or doctor for further treatment advice.

Skin contact: Wash off with soap and water. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice...

Eye contact: Hold eyelids open and flush with a steady gentle stream of water for 15 minutes. Remove contact lenses, if present, after the first 5 minutes, then, continue rinsing eye. Get medical attention.

Ingestion: Get medical attention if symptoms occur. Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

Most important symptoms/effects, acute and delayed: Severe eye irritation. Symptoms may include stinging, tearing, redness, swelling, and blurred vision.

SECTION 5 - FIRE-FIGHTING MEASURES

Suitable extinguishing media: Water fog. Foam. Dry chemical powder. Carbon dioxide (CO2).
