4. FIRST AID MEASURES

First aid measures

General advice	Immediate medical attention is required.
Skin Contact	Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. For minor skin contact, avoid spreading material on unaffected skin. For severe burns, immediate medical attention is required. Call a physician immediately.
Eye contact	Do not rub affected area. Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Keep eye wide open while rinsing. Call a physician immediately.

Indication of any immediate medical attention and special treatment needed

Note to physicians Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure. Treat symptomatically.

5. FIRE-FIGHTING MEASURES

Methods for cleaning up Dike far ahead of liquid spill for later disposal. Prevent product from entering drains. Soak up with inert absorbent material. Take up mechanically, placing in appropriate containers for disposal. After cleaning, flush away traces with water.
